



## INVITATION TO REGISTER AND UPDATING OF SUPPLIER DETAILS ON THE UMHLOSINGA DEVELOPMENT AGENCY SUPPLIERS' DATABASE

UMHLOSINGA DEVELOPMENT AGENCY pursuant to the provisions of the Municipal Finance Management Act (MFMA), Act 56 of 2003 read with the Supply Chain Management Regulation 14 (ii) invites suitable service providers of goods and services to apply for evaluation and listing as accredited prospective providers.

All service providers or suppliers who were previously or are currently providing services to the Agency are also invited to update or provide it with new and relevant information, and all mandatory documents shall be affixed eg. **SARS PIN to verify your tax compliance status, B-BBEE Certificate as issued by the verification agencies accredited by the South African National Accreditation System (SANAS) or Registered Auditors approved by the Independent Regulatory Board of Auditors (IRBA) in accordance with the approval granted by the Department of Trade and Industry (DTI) and Central Supplier Database Registration documents.**

All suppliers are encouraged to register onto the National Treasury's Central Suppliers' Database (CSD) by logging onto to the website address of <https://secure.csd.gov.za> or by logging onto National Treasury website address of [www.treasury.gov.za](http://www.treasury.gov.za) and click on the CSD Database.

**NB: A maximum of (2) commodities can be applied for by one supplier or service provider.**

Failure to submit the updated registration information could result in your information declared outdated and further restricted from rendering any services to Umhlosinga Development Agency.

Interested supplier's/services providers are requested to complete a registration form, obtainable at the Umhlosinga Development Agency's Offices, Lot 308, Ebony Crescent, Mtubatuba.

Responses should be submitted in a sealed envelope clearly marked Database Registration or be posted to **Umhlosinga Development Agency, P.O. Box 367, St Lucia, 3936 or be hand-delivered at the Agency's offices at Lot 308 Ebony Crescent, Mtubatuba.**
